Hakuto is a hybrid trading company and manufacturer specializing in the areas of electronics and chemicals.

Hakuto commenced business as a trading company importing electronics materials (crystals) from Brazil in 1953.

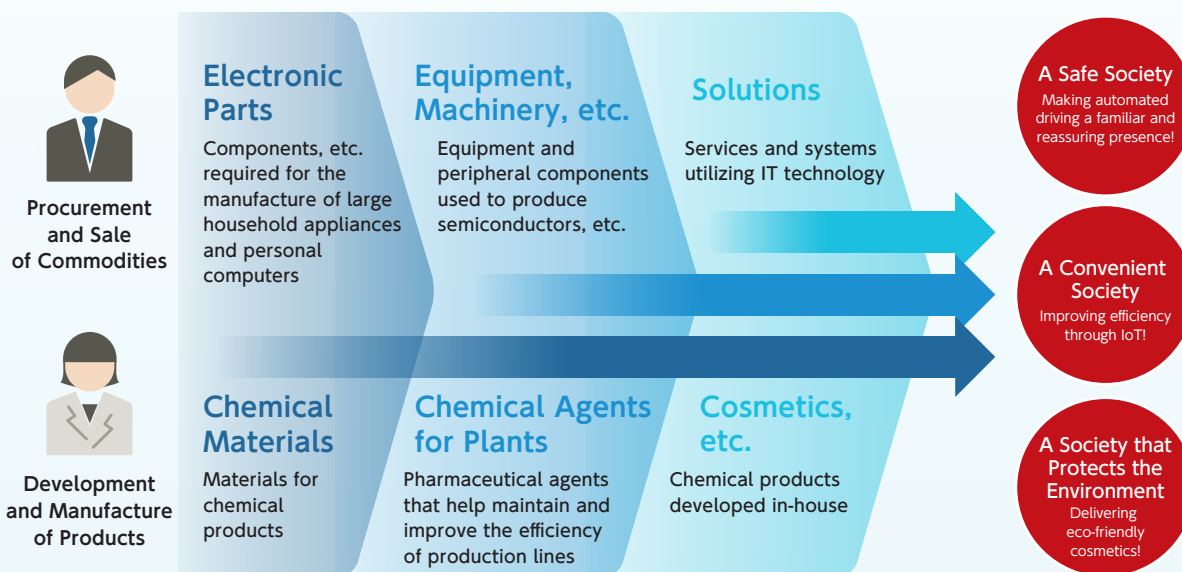
Today, we operate two businesses: as an electronics trading company and a manufacturer of chemicals.

We mainly procure and sell electronic materials, electronic parts, and equipment both in Japan and overseas. Electronic parts such as semiconductors account for the bulk of our sales.

In addition, we provide electronic equipment such as devices and measuring instruments used in research laboratories, factories, and other sites.

In recent years, we have also expanded our activities to encompass the provision of services and related equipment utilizing IT technology, including videoconferencing systems.

In chemicals, we mainly provide products developed in-house, as well as our original brand TAEKO products, which use our high-grade cosmetic base material Alcasealan.

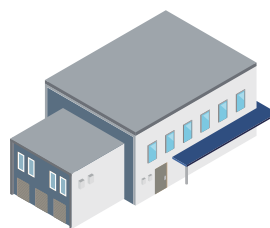

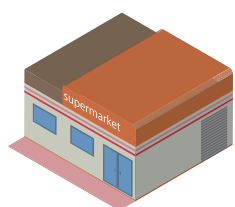

In recent years especially we have been promoting active investment in human capital to realize our basic principle that "Without the growth of employees, there is no growth of the company." accordance with our commitment to fostering female managers and expanding the scope of work done by female employees, we set up the Hakuto Women's College in October 2024. We are devoting much effort to the building of workplaces in which women can be more active.

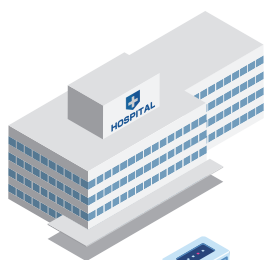

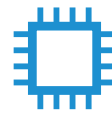


Provision of equipment and testing instruments to support manufacturing and development sites

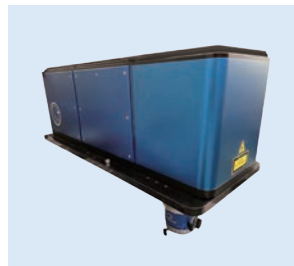

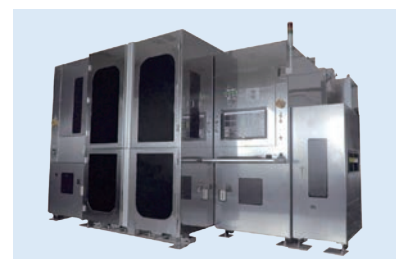

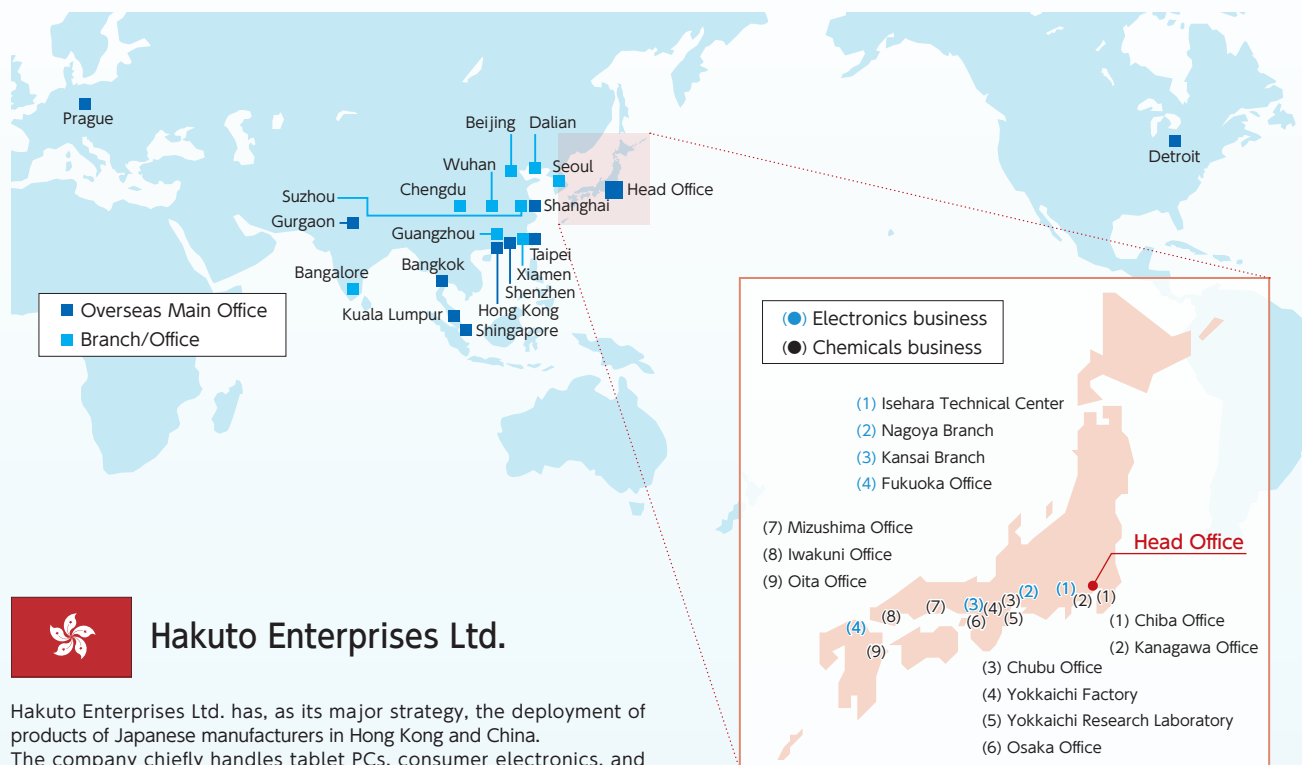
Global Business Development

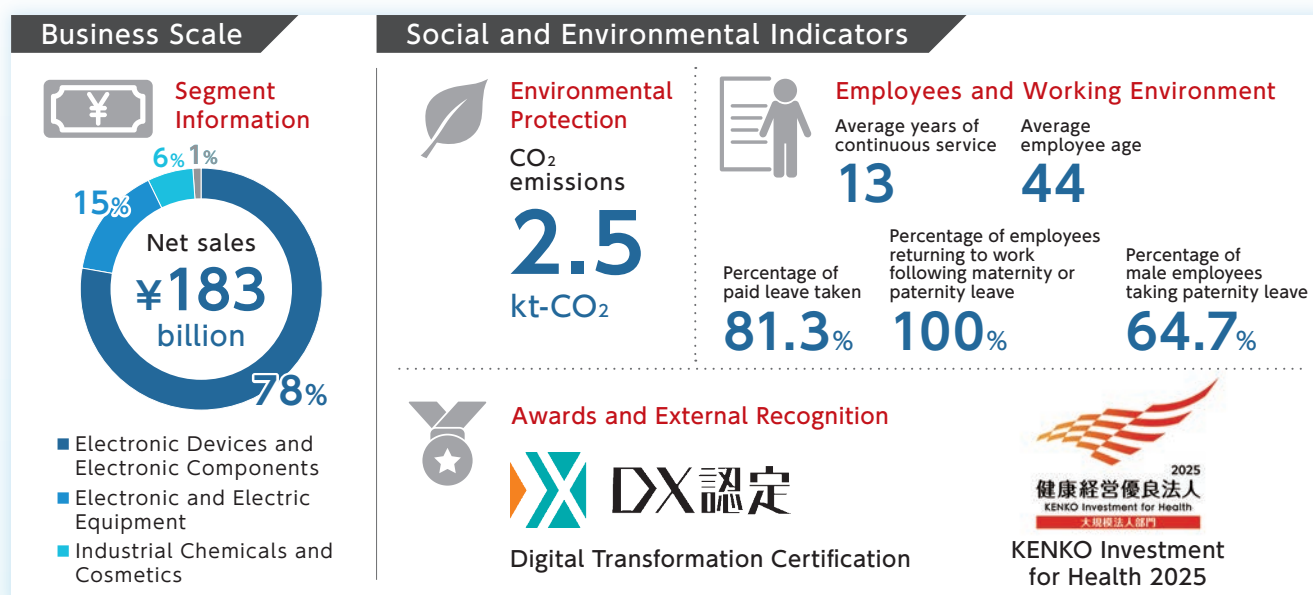
Corporate Information

Origin of the Company Name

Hakuto was established in 1953 as a trading company dealing in rough crystals. The name "Hakuto" was created by combining the reading ("haku") of the first of the Chinese characters used to render in Japanese the name of the country of Brazil, which is the area of origin of the rough crystals, and the first character of the Chinese character for the city of Tokyo ("to"). This name is intended to reflect our desire both to connect Brazil and Tokyo and for our company to play a vibrant role on the world stage.
